- 2.2 In his current role as an independent forensic scientist, Anthony is a professional member of the Chartered Society of Forensic Sciences and remains one of Europe's leading and most respected experts in this field, regularly attending international conferences and presenting academic papers on the subject. He is currently the Diploma manager for the Internationally recognised postgraduate Diploma in Questioned Document Examination and Handwriting awarded by the Chartered Society of Forensic Sciences.

- 2.3 During his career Anthony has examined thousands of documents and has dealt with many cases both simple and complex. Importantly, Anthony is a senior court reporting scientist and has given expert witness evidence and assisted counsel on countless occasions.
- 2.4 He carries out work for many prosecution authorities, including police forces, The Crown Prosecution Service and Government departments.
